A. SBOA-594 – David Castelli – 8460 Westway Road, more specifically known as Lot 19, Block 3, Timber Ridge Estates West subdivision, in the City of Sapulpa, Creek County, State of Oklahoma requests a VARIANCE, as allowed by the Sapulpa Zoning Code, to Section 240.2(E) of the Sapulpa Zoning Code for a 2,100 sq.ft. accessory building for secure storage of tractor, car collection and oversized trucks.

Urban Development Director Rachel Clyne presented the staff report and recommended approval.

The variance requests are is for an additional +/- 462 sq. ft in surface display area above the maximum 300 sq.ft. (total 762 sq. ft.) per billboard.
