Section 2: Restaurants, food courts, cafes, coffeehouses, and other places of public accommodation offering food and beverage for dine-in customers and guests are prohibited unless dine-in services at such locations are limited to no more thant four (4) individuals at each table and a minimum of six (6) feet of space and separation is maintained between tables and the location also offers curbside. drive-thru, takeout, and/or delivery services.

Section 3 (a): Bars, taverns, brew pubs, clubs, and other places of public accommodation offering alcoholic beverages for on-premises consumption, unless such location restricts services to no more than four (4) customers at each table and a minimum of six (6) feet of space and separation is maintained between tables.

Section 3 (c): Gymnasiums, fitness centers, recreation centers, indoor sports facilities, indoor exercise facilities, exercise studios, and spas. However, such facilities may operate with ten (10) or fewer total persons inside the facility at any time, by appointment only, provided such facilities are not open for walk-in business and each workout station is cleaned and sanitized between use by each customer.

Section 8: This proclamation shall become effective 11:00 P.M. Monday, March 23, 2020, and shall continue until 12:01 AM on April 6, 2020, unless terminated earlier by further proclamation.

#### **SUBJECT:**

### **BACKGROUND:**

On November 4, 2019, Council approved Resolution #4592 authorizing the calling and holding of an election for members of the Sapulpa City Council the general election is set for April 7, 2020. On March 18, 2020, the State Election Board declared an emergency regarding this election date due to the COVID-19 pandemic. As a result, the general election set for April 7, 2020 must be canceled and rescheduled to June 30, 2020.

#### **RESOLUTION NO.**

#### A RESOLUTION OF THE CITY OF SAPULPA, OKLAHOMA, RESCINDING RESOLUTION 4592, IN PART, DUE TO EMERGENCY DECLARED BY THE OKLAHOMA STATE ELECTION BOARD AND RESCHEDULING THE GENERAL ELECTION TO ELECT CITY COUNCILORS FOR THE CITY OF SAPULPA FROM TUESDAY APRIL 7, 2020, TO JUNE 30, 2020; AND NOTICE TO ELECTION BOARD.

**WHEREAS**, the Sapulpa City Charter Article X requires elections to be held every two years in the City of Sapulpa for the purpose of electing City Councilors of the City; and

**WHEREAS**, Title 26, Oklahoma Statutes 2012, Section 13-102, as amended, requires the City of Sapulpa, Oklahoma, to give sixty (60) days' notice by resolution of said election to the Creek County Election Board, stating therein the date of said elections and other information necessary for conducting such elections; and

**WHEREAS**, on March 18, 2020, the Oklahoma State Election Board declared an emergency regarding the COVID:18 pandemic which prevents holding the City's General Election for City Councilors currently set on April 7, 2020; and

**WHEREAS**, due to said emergency, the City's General Election for City Councilors set on April 7, 2020 needs to be rescinded and rescheduled to June 30, 2020, by notice from resolution to the Creek County Election Board.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Sapulpa, Oklahoma that, due to the election emergency declared by the Oklahoma State Election Board, the general election for City Councilors previously scheduled by Resolution 4592 for Tuesday, April 7, 2020, is hereby rescinded and rescheduled for June 30, 2020; and

**BE IT FURTHER RESOLVED** that said election shall be a nonpartisan general election and shall be held on Tuesday, June 30, 2020; and

**BE IT FURTHER RESOLVED** that the that the office to be filled by voting at said election is:

"Ward One, Seat Two, currently held by Wes Galloway"; and

**BE IT FURTHER RESOLVED** that the provisions of Resolution 4592 that are in conflict with this Resolution are repealed to the extent of conflict only and that all other portions of Resolution 4592 not in conflict herewith remain in force and effect.

#### PROCLAMATION OF THE CITY OF SAPULPA, OKLAHOMA, DECLARING STATE OF EMERGENCY

WHEREAS, the World Health Organization (WHO) has declared COVID-19 (Coronavirus) to be a global pandemic; and

WHEREAS, the President of the United States has declared an infectious disease national emergency declaration to combat COVID-19; and

WHEREAS, the Governor of the State of Oklahoma has declared an emergency by the impending threat of COVID-19 for all 77 Oklahoma Counties; and

WHEREAS, health professionals and researchers have determined that COVID-19 is spread by human interaction and interaction; and

WHEREAS, avoidance of human contact through methods such as social distancing is believed to stop the spread of COVID-19; and

WHEREAS, the spread of COVID-19 is a disaster affecting life, health and safety of Sapulpa residents and non-residents alike; and

WHEREAS, the Sapulpa Code of Ordinances along with State Law permit the Mayor of the City of Sapulpa to proclaim that a state of emergency exists within any area of the City:

#### NOW, THEREFORE, BY VIRTUE OF THE AUTHORITY VESTED IN ME BY THE STATE OF OKLAHOMA, I, LOUIS MARTIN, JR, MAYOR PRO TEM OF THE CITY OF SAPULPA, DO HEREBY PROCLAIM AND DECLARE:

SECTION ONE: A state of emergency exists within the corporate limits of the City of Sapulpa, Creek County, Oklahoma.

SECTION TWO: This proclamation shall become effective 12:01 PM March 17, 2020, shall continue until 12:01 AM on April 6, 2020, or until terminated earlier by further proclamation.

**SECTION THREE**: The following City of Sapulpa Facilities shall be closed to public use and all programming and events at said locations shall be postponed and/or canceled until the expiration of this emergency declaration:

Sapulpa Bartlett-Public Library Sapulpa Senior Citizen Community Center Booker T. Washington Recreation Center

The following City of Sapulpa facilities will remain open for individual access, however all public and private gatherings, meetings, and events with 50 or more participants are hereby postponed and canceled and no permits for gatherings, meetings, and events at said locations shall be issued until the expiration of this emergency declaration:

City of Sapulpa Parks City of Sapulpa Golf Course City of Sapulpa Lakes

**SECTION FOUR:** The City Manager shall revoke any pending permit and not issue any new permit for any public or private event on any City street, sidewalk, facility, park, or property until the expiration of this emergency declaration.

**SECTION FIVE:** Meetings of all City of Sapulpa authorities, boards, commissions, committees, and trusts are postponed and/or canceled until the expiration of this emergency declaration. All meetings of the Sapulpa City Council and Sapulpa Municipal Authority are exempt from this cancellation requirement. These meetings will remain open to the public but steps will be taken to ensure no close contact between attendees.

**SECTION SIX:** All Sapulpa Municipal Court traffic dockets are to be limited to less than fifty persons per docket and the juvenile court docket is postponed until May 2020 and will be rescheduled. Cases scheduled for arraignment, hearing, and trial will also all be rescheduled. The Municipal Judge shall issue an order rescheduling cases and the Municipal Court Clerk shall issue written notification of new court dates.

**SECTION SEVEN:** All in-person gatherings on private property with 50 or more participants for social, spiritual, and recreational purposes, including but not limited to community, civic, public, leisure, faith-based, or sporting events; parades, concerts, festivals, conventions, fundraisers and similar activities, are not prohibited but strongly discouraged until the expiration of this emergency declaration.

**SECTION EIGHT:** Restaurants, bars, and other privately owned gathering places are highly encouraged to limit the number of patrons such that at least six (6) feet of space is available to each patron. Such facilities are further encouraged to transition to "take-out" or "delivery" options.

**SECTION NINE:** Local gyms and exercise facilities are encouraged to discontinue all group activities and to limit the number of patrons such that at least six (6) feet of space is available to each patron and to significantly increase and enhance facility cleaning and disinfecting activity.
