2. <u>ADMINISTRATION.</u>

A. City Manager Joan Riley presented a list of suggested projects to be funded with General Obligation Bonds. She asked for input on which projects to fund. The city is currently at 14.35 mills. A General Obligation Bond election could be held in either October or December 2019 or possibly February or April 2020.

The committee discussed the various proposed projects, which total \$31,190,100.00: Public Safety - \$5,000,000.00; Route 66 Revitalization - \$3,400,000.00; Downtown Revitalization - \$2,000,000.00; Community - \$9,000,000.00; Economic Development - \$2,750,000.00; Infrastructure - \$450,000.00; Park and Recreation - \$8,590,100.00.

No action was taken by the committee.
